## Infrastructure

Environmentalism is prioritized through the development of resilient architecture.

The management of the built environment in both Rwanda and Indiana is challenging the previously unsustainable architectural norms of each respective region through the implementation of Green City Kigali (Rwanda) and the LEED Certification (USA). With a foundational focus of environmental promotion, LEED, a rating system in which the designs of buildings can be based, and Green City Kigali, a "green urbanization" investment fund, further **sustainable developments in modern infrastructure**.

# Industries

Economics is prioritized through the implementation of sustainable industrial policy.

"Industry increases productivity, job creation and generates income, thereby contributing to poverty eradication and addressing other development goals, as well as providing opportunities for social inclusion" (Lima Declaration).

Indiana and Rwanda are creating sustainable policy by not only prioritizing profit, but also providing access to basic goods and services. The governments of the two regions are moving toward accessible industries in various ways. Rwanda promotes industry through Ministry of Trade and Industry (MINICOM) which favors investors. Similarly, Indiana does so through the International Trade Department which helps companies explore opportunities for exporting their products around the world. In turn, this increases business revenue and produces more Indiana jobs.
